A Reminder About Community Rules

Please be aware that the rules that currently governing our community are the 2008 Rules and Regulations. If you do not have a copy of these rules, you may go to the web site and download a copy or contact the management company for a copy.

The management company will also be sending a copy via email to all owners that have an email on file. Those who do not have an email on file will be mailed a copy. The Rules committee is in the process of updating the rules, however, we want to make all residents aware that there are current rules that will be enforced.

If you see a violation of the rules and regulations, you must submit your complaint in writing to the Board of Directors. There is a form on the web site. Fill this out and submit to the Board via the management company. If you do not have access to the web site, you may contact the management company for a copy.

Thank you for your help keeping the Fountains community a safe, pleasant place for all who live here. In particular, please observe the following rules.

Garage Doors (See Rules, Section I, B4, B6)

Garages must be kept clean and safe. No activity that would be a health, fire or safety hazard and/or noise or other nuisance is permitted. Flammable products such as paint, oil or thinner must be stored in suitable containers and marked as such. No gasoline or open containers of oil may be stored.

Garage Doors should normally remain closed.

Pets (See Rules, Section 5H)

Dogs are not allowed on grassy areas next to guest parking or in the northeast corner of the complex. All dogs must be waked on the promenade.

Traffic and Parking (See Rules Section 7, A, 2)

The streets of The Fountains and garage entry aprons are designed for vehicular traffic and are not designed for parking vehicles.
